SCOPE

DieselHub.com ("We", "we", "Our", "our") is greatly committed to protecting the privacy of our users ("You", "you") and providing a safe, high quality experience in the delivery of our services. This privacy policy describes 1) What information is collected from our users, 2) How information is collected from our users, 3) How collected information is used and protected, and 4) Your rights under the California Consumer Privacy Act. APPLICATION

This privacy policy applies to all users regardless of geographic location, the device(s) on which Dieselhub.com is being accessed, and/or their intentions for using our services.

DEFINITIONS

Data controller – the person(s), company, or entity that determines what data is collected from users, how this data is stored, and how this data is used.

- User's internet protocol (IP) address
